Probable Cause Affidavit

Before me this date personally appeared GALLARDO, JOSHUA (16900) who being first duly sworn deposes and says that on 18 day of July, (year) 2015 at 7707 W COMMERCIAL BLVD, TAMARAC, (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

shirt, blue shorts approach me from behind (later identified as Elberg M. Gelin) while attending to a victim of a battery. I advised the black male to move back, that this is a crime scene. He advised he was recording the incident and that he did not have to move. I advised him he could continue to record but that he would have to move back behind the bushes to the east side to provide space for when rescue comes. He failed to comply with my commands to move from the area. I repeatedly requested that he leave the area and not continue to approach me from behind. I then reproached the suspect and advised him he was under arrest. While attempting to handcuff the subject he pulled his hands away from me and put his phone in his pocket. He was placed into custody for resisting w/o violence and transported to BSO Main jail.
